Gift Description:

The undersigned Donor hereby irrevocably transfers and donates to the Recipient Organization the property described as follows: _____, including all rights, title, and interest therein (the "Gift").

Purpose of Gift:

This Gift is made for the charitable purposes of the Recipient Organization and shall be used in accordance with its exempt purposes under the Internal Revenue Code and other applicable laws and regulations.

Donor Representations and Warranties:

Recipient Organization Acknowledgment:

The Recipient Organization acknowledges receipt of the Gift described above and agrees to use the Gift in furtherance of its exempt purposes. The Recipient Organization will provide the Donor with a written acknowledgment consistent with IRS requirements for charitable contributions.

Tax and Legal Compliance:

The Donor understands that this Gift may be tax deductible under applicable law and that the Recipient Organization will provide no goods or services in exchange for the Gift. Donor agrees to consult with their own legal and tax advisors regarding the deductibility and legal effect of this Gift.

Indemnification:

Donor agrees to indemnify and hold harmless the Recipient Organization, its directors, officers, employees, and agents from any claims, liabilities, damages, or expenses arising from Donor's representations or ownership of the Gift.

Governing Law and Jurisdiction:

This Letter of Gift shall be governed by and construed in accordance with the laws of the United States and the State in which the Recipient Organization is located, without regard to conflict of law principles. Any disputes arising hereunder shall be subject to the exclusive jurisdiction of the state or federal courts located therein.

Entire Agreement:

This Letter of Gift constitutes the entire agreement between Donor and Recipient Organization concerning the Gift and supersedes all prior understandings, whether written or oral. No amendment will be effective unless in writing and signed by both parties.
