Limitation of Liability:

The carrier's liability for loss, damage, delay, or other claims shall be limited to the extent permitted under applicable federal and state laws and regulations, including but not limited to the Carmack Amendment (49 U.S.C. § 14706) and any other relevant statutes. The undersigned agrees that any claims must be filed within the time frames prescribed by law and in accordance with carrier policies.

Indemnification:

The undersigned agrees to indemnify, defend, and hold harmless the carrier, its agents, employees, and contractors from and against any and all claims, damages, losses, liabilities, costs, and expenses (including reasonable attorneys' fees) arising out of or related to the shipment, except to the extent caused by the carrier's gross negligence or willful misconduct.
