Terms and Conditions:

This Letter may be terminated by mutual written agreement of the Parties. Termination shall not affect any rights or obligations incurred prior to termination. In the event of termination, the Parties agree to settle all outstanding arrangements and obligations in good faith.

Dispute Resolution:

Any disputes arising out of or related to this Letter shall be resolved through mediation, and if unresolved, through binding arbitration under the rules of the American Arbitration Association or a similar recognized body. The place of arbitration shall be mutually agreed upon by the Parties.

Governing Law:

This Letter shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of laws principles.

Acknowledgement:

The Parties acknowledge that they have read and fully understand the terms of this Letter, and that they enter into it voluntarily and without duress. This Letter constitutes the entire agreement between the Parties regarding the subjects herein and supersedes any prior agreements or understandings.
